Rule #222.2	Voluntary Early Retirement Procedures (recommend delete): The committee reviewed the rule being recommended for deletion. The committee did not agree to delete this rule. The committee requested this rule along with the policy go to the BOE Negotiations Committee for review and revisions to make the administrator contracts and the policy/rule correspond. The BOE Negotiations Committee will provide a recommendation to the BOE Policy Committee for an upcoming meeting.

Policy #223	Administrator Development Opportunities (revise): The committee reviewed the revised policy. It was recommended any language stating, "superintendent" be revised to say "District Administrator". The committee recommended the revised policy go to the full board as a first reading with these recommended revisions.
Policy # 330	Curriculum Development and Evaluation (revise): The committee reviewed the revised policy. The committee recommended leaving the first paragraph in the policy and revising the third sentence to read, "Therefore, the Board of Education shall review and adopt a District curriculum which, to the extent possible, reflects the desires of the community, the needs of society, and the requirements of state and federal law". The committee recommended the policy go to the full board as a first reading with these recommended revisions.
Rule #330	Curriculum Development and Evaluation Guidelines (recommend delete): The committee reviewed the rule recommended for deletion. There were no recommended revisions. The committee recommended the rule go to the full board as a first reading for possible deletion. Barb Sparish will rewrite this rule and present it to the BOE Policy Committee at their October meeting.
Policy #333	Parent Rights and District Programs/Activities (revise): The committee reviewed the revised policy. It was recommended the underlined language under #1(d) be deleted. The committee recommended the policy go to the full board as a first reading.
Policy #342.5	Gifted and Talented Program (revise): The committee reviewed the revised policy. The fourth paragraph reading, "the identification process and tools shall be responsive to factor such as, but not limited to, students' economic conditions, race, gender, culture, native language, and developmental difference" was recommended to be deleted as it was a duplicate of the language already in #4. The committee recommended the policy go to the full board as a first reading with these recommended revisions.
Rule #342.5	Gifted and Talented Procedures (revise): The committee reviewed the revised rule. They recommended #5 be revised to read, "Within 30 calendar days of receiving consent to gather more information, a meeting will be held with all relevant staff members and parents to review the results of the information collected and determine eligibility for the Gifted and Talented Program." This was revised from 60 calendar days to 30 calendar days. The committee recommended the rule go to the full board as a first reading with the recommended revision.
Policy # 343.2	Youth Options (revise): The committee reviewed the revised policy. It was recommended the language in #4 under the title of Youth Options Courses through a Technical College, regarding good academic standing, be added under the title of Youth Options Courses through an Institution of Higher Education as well. The committee recommended the revised rule go to the full board as a first reading with these recommended revisions.

It was recommended that administration spend some time reviewing middle school data and revising this policy to be specific on retention criteria, specifically to hold 7 th and 8 th grade students accountable for completing assignments and making sure they are ready for the transition to high school. The committee shared the current policy allows for moving students ahead a grade even if they are not ready. The committee recommended the policy and rule be placed on hold until the process can be reviewed and the policy and rule can be revised if needed. This will be brought back to the committee at a future meeting.
Rule #344.4	Guidelines for Grade Retention, Promotion, and Acceleration of Students (revise): The committee reviewed the revised rule. The committee recommended the policy and rule be placed on hold until the process can be reviewed and the policy and rule can be revised if needed. Policy #344.41	Grade Advancement Grades 4 and 8 (recommend delete): The committee reviewed the policy recommended for deletion.
