- I. **CALL TO ORDER:** The meeting was called to order at 5:40 p.m.

- III. **NOTICE OF POSTING:** Randy Drost announced that notice of the meeting was communicated by public notice as required by 19.84 of WI statutes.

- IV. **Approval of Minutes from Tuesday, August 8, 2017:** Gary Spear and Keven Jensen motion to approve the committee meeting minutes from Tuesday, August 8, 2017. All present voting yes. Motion approved.

- V. **REVIEW THE FOLLOWING:** The board reviewed the following policies:

Policy	Title
Policy #222.2	Voluntary Early Retirement for Administrators (review): The committee reviewed the current policy. There were no additional recommended revisions. The committee recommended the revised policy go to the BOE Negotiations Committee along with the revised rule.
Rule #222.2	Voluntary Early Retirement Procedures (review): The committee reviewed the current rule. The committee recommended the revised rule go to BOE Negotiations Committee for review and possible revisions. The board will hold a closed session meeting on Monday, October 9, 2017 to help direct the board on legal counsel.
Policy #330	Curriculum Development and Improvement (revise): The committee reviewed the revised policy. The committee requested linking the district's curriculum plan and curriculum guides on the district website. The committee will have Randy Drost develop a process for overseeing and evaluating the schedule for each area of study covered by the district's sequential curriculum guides. The results of each evaluation will then be reported to the Board of Education as well as any recommendations for possible Board action. The committee recommended the revised policy go to

Rule #330	Curriculum Development and Evaluation Guidelines (revise): The committee reviewed the revised rule. The committee recommended the revised rule go to the full board as a first reading.
Policy #341.21	School Wellness Policy on Physical Activity and Nutrition (revise): The committee reviewed the revised policy. It was recommended the link for the local school wellness policy from the USDA website be linked into the policy. There was also a recommendation to include the word, “wellness” before committee throughout the policy for clarification. The committee recommended the revised policy go to the full board as a first reading.
Rule (1) #341.21	School Nutrition Standards (revise): The committee reviewed the revised Rule (1). There was a request to include a definition on page 1 of “Competitive Foods”. The committee recommended the revised Rule (1) go to the full board as a first reading.
Rule (2) # 341.21	Physical Activity (revise): The committee reviewed the revised Rule (2). Gary Spear and Keven Jensen motion to table Rule (2) of Policy #341.21 until the next BOE Policy Committee meeting. All present voting yes. Motion approved. The physical education representatives of the District Wellness Committee will be invited to the next meeting to provide clarification on Rule (2).
Policy #442.2	Student Conduct on School Buses (revise): The committee reviewed the revised policy. On page 2, the title “Bus Expectations” will be revised to read, “Bus Rider Rules”. Under Bus Misconduct, a fourth and fifth bullet will be added: <i>The fourth written referral: The principal meets with the student and calls the parent. The student’s bus riding privileges may be suspended to the end of the current semester or the end of the school year. The fifth written referral: a student who is suspended from bus riding privileges will not be allowed to ride the bus to field trips or extra-curricular activities.</i> The committee recommended the revised policy go to the full board as a first reading.
Rule #442.2	School Bus Rider Rules and Procedures (recommend delete): The committee reviewed the rule recommended for deletion. There were no revisions recommended. The committee recommended the rule go to the full board as a first reading for possible deletion.
Policy #751.1	Student Transportation In Alternative Vehicles (revise): The committee reviewed the revised policy. Gary Spear and Keven Jensen motion to table the policy and rule #751.1 until the next BOE Policy Committee meeting. All present voting yes. Motion approved.
Rule #751.1	Authorization of Alternative Vehicles and Drivers to Transport Students (new): The rule was tabled until the next BOE Policy Committee meeting.
