- Early Childhood, Head start teachers, PK teachers are trained in the district literacy system and provide ongoing professional development on literacy, math, and PBIS
- Students visit school sites in the spring of every year (Child Development Days)
- Conduct monthly collaborative organizational meetings for all early childhood educators
- Include Pre-K and early childhood students in all K-4 elementary events
- Provide literacy information to parents of pre-school aged children that attend private day care

**Criteria 8: Measures to include teachers in decisions regarding the use of academic assessments to provide information on, and to improve, the achievement of individual students and the overall instructional program.**

- Conduct building level data retreats three times per year
- Title 1 interventions support what is being taught in the general education settings
- Benchmark assessments align with general education literacy framework

**9. Effective, timely assistance of interventions for students who experience difficulty in attaining the proficient or advanced level of the academic content standards. Students' difficulties must be identified in a timely way and in such a way as to provide information on which to base effective assistance of interventions.**

- A collaborative team reviews the benchmark results within 2 weeks of completion of the assessments.
- District has determined interventions and processes for accessing the interventions as part of the assessment process.
- Transition from assessment to intervention is seamless and procedures are in place and followed.
- Interventions are reviewed and monitored for progress in order to address the student's ongoing needs.
